The Department has prepared a draft permit and has made a tentative determination, subject to public comment or other information, to approve the reauthorization of existing discharge of 15,000 gallons per day of treated wastewater to an unnamed subtributary of Silver Stream Reservoir (AKA Browns Farm Pond or Browns Farm Reservoir) from a secondary treatment plant at the applicant's facility address located at 1 Nevis Dr, New Windsor, NY 12553. The facility is a mobile home park. The previous permit lapsed on October 31, 2022.
